

RV SALES CONSIGNMENT AGREEMENT

Thanks for letting us help sell your RV. This agreement covers how it works between you (the Owner) and Journey USA RV Rentals. Keep a copy, sign at the bottom, and we'll take it from there.

1. How long & what we charge. We'll list your RV for 3 months, or until it sells. Our fee is 8% of the sale price or \$1,000 — whichever is higher — taken from the sale proceeds at closing, so you don't pay anything up front.

2. You can still look for buyers too. Feel free to keep looking for buyers on your own. If you find one with no help from us, you don't owe us anything. If we've already put real time, storage, or marketing into it, we'll have a friendly conversation about fair compensation before you close that outside sale.

3. Storage, inspection, and repairs. Lot storage is included while we're actively marketing your RV at a realistic price. If a unit sits long-term at a price the market won't support, we may need to start charging \$100/month — but only after a heads-up conversation with you first. We may also want a quick pre-listing inspection (\$110), and we never do repairs without your sign-off.

4. Insurance & risk while it's with us. Please keep your own insurance on the RV while it's listed, including while it's on our lot. Your insurance is primary. We aren't responsible for damage, theft, weather, fire, or anything left inside — please grab valuables before drop-off.

5. What you're telling us. You confirm you own the RV (or are authorized to sell it) and you'll tell us about any known issues — defects, accident history, water damage, or liens. The RV sells as-is. We act on your behalf, not as the seller, so anything undisclosed that surfaces after the sale is between you and the buyer.

6. Marketing & photos. We'll market your RV wherever it sells best — Facebook Marketplace, RV Trader, our website, Google. You're giving us permission to use photos and content of the RV on those channels. Photos and content we create stay ours.

7. How you get paid. When the RV sells, we deduct our commission and any storage, inspection, or repair costs from the sale proceeds, then send you the rest once funds clear and title transfer is underway. Any lien is paid directly to the lender. We keep a credit card on file but won't charge it beyond fees listed here without checking with you.

8. Ending the agreement & legal stuff. Either of us can end this anytime with a quick email. You'll still owe any fees that built up before that. No commission is owed unless a sale is already in motion. This agreement follows Florida law and is the entire agreement between us — changes must be in writing.
